#### E. Cost Proposal

We propose to charge the Township as follows:

- 1. For Township Attorney, a monthly retainer in the sum of \$5,000 per month. This will include attendance at all meetings with the Township Council, Township Manager, and any other Department Heads or committees as needed, as well as all in-person, e-mail, and telephonic communications unless otherwise specifically described below.
  - We will also charge a blended rate of \$165 per hour for all attorneys in all other matters, including litigation and drafting resolutions, ordinances, contracts, memoranda, and other legal documents, in addition to any necessary costs or expenses, which will be billed at cost. We will not charge for time spent by paralegals or other support staff.
- 2. **If we are engaged separately as litigation, tax appeal, OPRA, or labor counsel**, we will charge at a blended rate of \$165 per hour, in addition to any necessary costs or expenses. We will not charge for time spent by paralegals or other support staff.

We are willing to work with the Township on the retainer amount and/or hourly rate of compensation as needed to accommodate the Township's needs and budget.

We note the Township's request in the RFQ for a statement as to the availability of a member of the Firm to work on-site in Teaneck for three-to-four days per week, up to 25 hours per week. While we may be able to do so for one-to-two days per week, if needed, we note that we are available around-the-clock for all of Teaneck's needs, whenever they arise. If there is an issue that requires us to be present in Teaneck, any day of the week, we will ensure that we are there as needed.
